**M**organ Chu is a partner at Irell & Manella and one of the most recognized names in IP litigation. Chu has secured many of the world's largest, and in some cases precedent-setting verdicts, judgments and settlements, including most recently obtaining a \$2.2 billion jury verdict in March 2021 for VLSI Technology in a suit against Intel involving microprocessor technology patents. Chu also secured a \$1.2 billion judgment in April 2020 and the largest patent jury award of 2019 for Sloan Kettering Institute for Cancer Research and Juno Therapeutics in a suit against Kite Pharma involving a cancer immunotherapy patent. Additionally, Chu argued and won a 9-0 U.S. Supreme Court decision in December 2019 on behalf of NantKwest, persuading the justices to strike down a U.S. Patent and Trademark Office policy that applicants who appeal to a district court must foot the office's legal bills, no matter who wins.

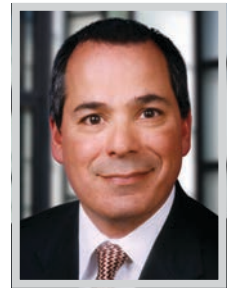

**M**ike De Vries is currently in his fourth in-person jury trial since the start of COVID-19. U.S. District Judge Laura Schofield who presided over Syntel v. TriZetto told jurors it was "in some ways a historic event." Everyone in the courtroom wore face coverings, and counsel and the witnesses stood inside plexiglass boxes when speaking, as a HEPA filter ventilated the courtroom. Kirkland attorneys reported that "you couldn't read the judge's expression, you couldn't read a juror's expression." Counsel was even forbidden from passing notes or whispering to co-counsel who were presenting. Despite the challenges that COVID-19 posed, De Vries secured \$1.62 billion in two separate plaintiff-side jury verdicts won in 2020 alone. In addition to obtaining extremely favorable outcomes for his clients, these trial victories implicate important national and geopolitical issues, influencing IP protection strategies and guiding the adaptation of trial advocacy in technology disputes.

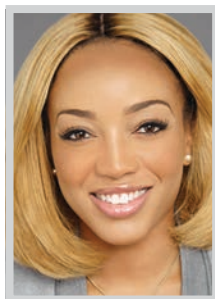

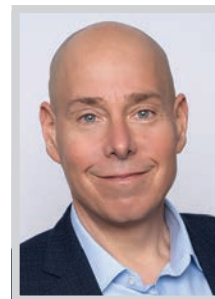

He obtained a stay of the California suit, and two were consolidated last year. He also secured a victory in a suit alleging a Honda motorcycle had a design flaw. He filed a demurrer arguing that the dealer agreement contained a choice-of-law provision identifying California law including California's statute of limitations, and that plaintiffs could not displace California law with Missouri's law, which had a longer limitations period. Court agreed with AHM's statute of limitations argument, sustaining the demurrer with leave to amend.

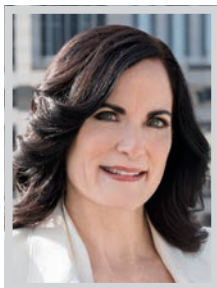

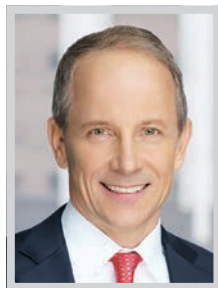

Amazon* obtained a complete defense judgment after a two-week trial in a case promoted by eBay as an international RICO and fraud conspiracy to unlawfully recruit eBay sellers to Amazon.

Over the past year, he has successfully represented the County of Los Angeles against numerous lawsuits challenging the enforcement of emergency health orders, such as contact-tracing, stay-at-home orders, and orders restricting activities to reduce the spread of the virus. For example, Siegel successfully represented LA County against a Beverly Hills sushi restaurant after the county issued its COVID-19 contact-tracing order; and also obtained a preliminary injunction against a mega-church defying indoor service restrictions.

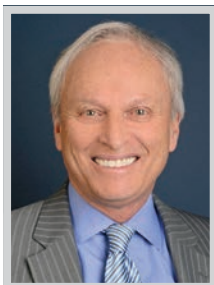
